

Opći uvjeti izlaganja na ZGrappa međunarodnom festivalu rakije i likera (DIXI d.o.o., Mikulići 74, Zagreb, Hrvatska)

Opći uvjeti izlaganja primjenjuju se jednako na sve izlagače ZGrappa festivala rakije i likera

1. Organizator je DIXI d.o.o., Mikulići 74, Zagreb, OIB 55448735519
2. Pravo sudjelovanja na ZGrappi imaju sve fizičke i pravne osobe koje su izvršile pravovremenu uplatu prema ponudi Organizatora (u daljnjem tekstu Prijava). Jedino pravovremenom uplatom izlagač osigurava festivalsku poziciju na ZGrappi.
3. Organizator temeljem zaprimljenih prijava vrši podjelu izložbenog prostora. Ukoliko se pojave nepredviđene okolnosti Organizator ima pravo opozvati potvrđenu i dodijeliti zamjensku festivalsku poziciju u interesu festivala, a izlagač zbog toga nema pravo otkazati sudjelovanje ili postavljati zahtjeve za promjenom, te nema pravo tražiti naknadu štete. Pod nazivom «izlagač» organizator smatra sve osobe koje rade po nalogu izlagača.  
  
Organizator se obvezuje predati izlagaču štand i naručenu opremu 3 sata prije početka manifestacije, a sve eventualne reklamacije primaju se isključivo u pisanom obliku do najkasnije 30 minuta prije početka Festivala. Izlagač mora dozvoliti prolaz svih vrsta instalacija preko svoje festivalske pozicije, a koje su neophodne za tehničko ili drugo uređenje festivalskog prostora, odnosno festivalske pozicije drugog izlagača. Izlagač može na izlagačkoj poziciji u svakom trenutku imati maksimalno 3 osobe kojima Organizator osigurava ulaz, sve ostale osobe dužne su kupiti ulaznicu.
4. Izlagač je dužan dostaviti popis robe koju će Organizator za njih prodavati na festivalu najkasnije do 30.9.2023.
5. Za prodaju robe na pop up štandu izlagač je dužan dostaviti Otpremnicu, a Organizatoru će izdati fakturu prema količini prodane robe po završetku festivala.
6. Izlagačima nije dopušteno odstranjivanje izložbenih eksponata ni opreme sa izložbenog prostora prije zatvaranja festivala. Radno vrijeme ZGrappe za posjetitelje je prvi i drugi dan od 12:00 do 20:00 sati. Izlagači su odgovorni sanirati sva oštećenja koja se njihovom krivnjom dogode na festivalu.
7. Obvezu osiguranja izložbenog prostora preuzima Organizator, te se obvezuje organizirati zaštitarsku službu tijekom trajanja festivala. Osiguranje izložaka na svakom pojedinom štandu obveza je izlagača. Organizator i tehnički realizator festivala nisu odgovorni za štetu, gubitke ili otuđenje izlagačeva vlasništva. Također, nisu odgovorni za eventualni nestanak stvari sa štanda za vrijeme dok je izlagač prisutan na štandu, tj. u radno vrijeme festivala za posjetitelje. Izlagač je obavezan ostati na svom štandu dok se sajamski prostor ne isprazni sa posjetiteljima, pa čak ako to zahtijeva određeno vrijeme nakon radnog vremena manifestacije. Nije dopušteno napuštanje izložbenog prostora prije zatvaranja festivala.

8. Izlagač je dužan ukloniti izložbene eksponate po završetku izložbe prvi i drugi dan u 20 sati, radi programa koji će se odvijati nakon izložbe.
9. Izlagaču nije dopušteno davati u zakup prostor trećoj osobi bez odobrenja Organizatora.
10. Izlagač se obvezuje donijeti pića koja je prijavio, te će ih služiti za vrijeme trajanja manifestacije.
11. Izlagač je obavezan postaviti pića na svom štandu i završiti s opremanjem štanda jedan sat prije početka festivalske priredbe.
12. Organizator se obvezuje izlagaču dostaviti stol sa stolnjakom, pljuvačnicu, 3 kg leda, natpis s imenom izlagača za štand i izvor struje.
13. Izlagači su sami odgovorni za unošenje pića i ostalih eksponata u svom vlasništvu.
14. Organizator ne osigurava parkirališna mjesta u radno vrijeme trajanja festivala te izlagač sam skrbi o parkiranju vozila.
15. Prijava je neopoziva i obavezuje, a otkazivanje je obavezno dostaviti u pisanom obliku. Ukoliko izlagač otkáže sudjelovanje najkasnije 15 dana prije početka izložbe povratit će mu se 50% ugovorene vrijednosti izložbenog prostora. Za otkazivanje sudjelovanja izlagača u roku od 15 dana i manje od početka izložbe izlagač gubi pravo na povrat sredstava.
16. Za uništenu imovinu koja je u najmu za vrijeme trajanja Izložbe, izlagač preuzima obavezu za naknadu štete.
17. O čišćenju cjelokupnog prostora skrbi Organizator, a čišćenje Festivalске pozicije obveza je izlagača.
18. Izlagač plaćanjem ponude Organizatora pristaje na Opće uvjete.
19. Eventualne sporove između izlagača i organizatora stranke će rješavati dogovorno, a ukoliko to ne uspiju utvrđuju nadležnost suda u Zagrebu.

General conditions of exhibition at the ZGrappa International Brandy and Liqueur Festival (DIXI d.o.o., Mikulići 74, Zagreb, Croatia)

The general exhibition conditions apply equally to all exhibitors of the ZGrappa brandy and liqueur festival.

1. The organizer is DIXI d.o.o., Mikulići 74, Zagreb, OIB 55448735519
2. The right to participate in ZGrappa has the right to all natural and legal persons who have made a timely payment according to the offer of the Organizer (hereinafter referred to as Application). Only with timely payment does the exhibitor secure a festival position at ZGrappa.
3. Based on the applications received, the organizer divides the exhibition space. If unforeseen circumstances arise, the Organizer has the right to revoke the confirmed and assign a replacement festival position in the interest of the festival, and the exhibitor therefore has no right to cancel participation or request a change, and has no right to claim compensation. Under the name "exhibitor", the organizer considers all persons who work on behalf of the exhibitor.

The organizer undertakes to hand over the stand and the ordered equipment to the exhibitor 3 hours before the start of the event, and all possible complaints are received exclusively in writing no later than 30 minutes before the start of the Festival. The exhibitor must allow the passage of all types of installations over his festival position, which are necessary for the technical or other arrangement of the festival space, or the festival position of another exhibitor. The exhibitor can have a maximum of 3 people at the exhibitor's position at any time, for whom the Organizer provides entrance, all other persons are required to purchase a ticket.

4. The exhibitor is obliged to submit a list of goods that the Organizer will sell for them at the festival no later than September 30, 2023.
5. For the sale of goods at the pop-up stand, the exhibitor is obliged to submit the Delivery Note, and will issue an invoice to the Organizer according to the amount of goods sold at the end of the festival.
6. Exhibitors are not allowed to remove exhibits or equipment from the exhibition area before the closing of the festival. The opening hours of ZGrappa for visitors are the first and second day from 12:00 to 20:00. Exhibitors are responsible for repairing all damages that occur at the festival through their fault.
7. The Organizer undertakes the obligation to secure the exhibition space, and undertakes to organize a security service during the duration of the festival. Securing the exhibits at each individual stand is the responsibility of the exhibitor. The organizer and the technical implementer of the festival are not responsible for damage, losses or alienation of the exhibitor's property. Also, they are not responsible for the possible disappearance of things from the stand while the exhibitor is present at the stand, i.e. during the working hours of the festival for visitors. The exhibitor is obliged to stay at his stand until the

fair space is empty with visitors, even if this requires a certain time after the opening hours of the event. It is not allowed to leave the exhibition area before the closing of the festival.

8. The exhibitor is obliged to remove the exhibition exhibits at the end of the exhibition on the first and second day at 20:00, for the sake of the program that will take place after the exhibition.

9. The exhibitor is not allowed to lease the space to a third party without the approval of the Organizer.

10. The exhibitor undertakes to bring the drinks he registered, and will serve them for the duration of the event.

11. The exhibitor is obliged to place the drinks on his stand and to finish equipping the stand one hour before the start of the festival event.

12. The organizer undertakes to provide the exhibitor with a table with a tablecloth, a spittoon, 3 kg of ice, an inscription with the name of the exhibitor for the stand and a power source.

13. Exhibitors are responsible for bringing in drinks and other exhibits in their possession.

14. The organizer does not provide parking spaces during the working hours of the festival, and the exhibitor is responsible for parking the vehicles.

15. The application is irrevocable and binding, and the cancellation must be submitted in writing. If the exhibitor cancels participation no later than 15 days before the start of the exhibition, 50% of the contracted value of the exhibition space will be returned to him. For canceling the exhibitor's participation within 15 days or less from the beginning of the exhibition, the exhibitor loses the right to a refund.

16. For destroyed property that is rented for the duration of the Exhibition, the exhibitor assumes the obligation to compensate for the damage.

17. Cleaning of the entire area is the responsibility of the Organizer, and cleaning of the Festival position is the responsibility of the exhibitor.

18. By paying the Organizer's offer, the Exhibitor agrees to the General Terms and Conditions.

19. Any disputes between the exhibitor and the party organizer will be resolved by agreement, and if they fail to do so, they will determine the jurisdiction of the court in Zagreb.
